The Dallas Police Department was NIBRS certified June 2018 with Crime Data from March of 2018 forward. All crime counts prior to March 2018 are calculated using the NIBRS counting rules but are not recognized as officially NIBRS. Crime counts are based on UCR NIBRS rules therefore, cannot be compared to crime counts based on UCR Summary rules. These statistics are preliminary counts of the original police incident reports and may vary from the final UCR (Uniform Crime Reporting) statistics published by the FBI. The above NIBRS crime statistics listed are not final and sometimes adjusted throughout the year due to re-classifications after being investigated or reports filed at a later date by a victim on a daily basis.
