- Officer David Kim reviewed our July 2022 crime statistics, noting that we continue our "low" crime stats :
  - NO violent crime for July 2022
  - Non-violent crime for WHHA remains in GREAT status.
    - 4 property/residence break-ins and BMV (Peter Pan area)
    - Non – violent crime down 50% from last year
    - BMV down 44% from last year
    - Sr. Corporal Chris Taylor was introduced as the VIP program coordinator
      - Quarterly classes for new VIP members will be offered. The next class will be held September 17, 2022.
      - Current VIP members should ensure their name & address are correctly noted. A current background check may need to be completed. Bob will keep us posted on the need for new background checks.
      - It was noted that several current VIP members still do not have VIP badges. Bob will follow-up.
