#### **Dallas Police Department:**

Officer Kim's update:

- Officer David Kim reviewed our June 2022 crime statistics, noting that we continue our "low" crime stats:
  - Non-violent crime for WHHA remains in GREAT status.
  - o Burglary of a business was noted, after homeowner permitted entrance to a purported utility worker, then believed to have recognized loss of property from inside the home.
  - O Coffee with Cops will be held July 15, 2022 at Starbucks, 11844 Josey Lane from 9-11 am. Everyone is encouraged to come for a quick visit with our local DPD team!
  - NW unit is close to reaching the 9-person team, and hopes to participate in more community events & services with the increased people-power.

#### City of Dallas:

Code Compliance attended the June 2022 meeting. LaShonna Slider was accompanied by her manager, Odie Hayes. LaShonna provided several useful handouts to our VIP group, including Brush/Bulky Item 2022 Calendar, West Nile Virus avoidance techniques, and Chemical Collection Center information.
