OfficerLeee's update:

- Officer Lee reviewed our October 2022 crime statistics, noting that we may be "the safest place in the city"!
 - NO violent crime in WHHA
 - Non-violent crime:
 - 2 BMV incidents over the past month, both unlocked vehicles (1 at El Rancho, 1 on Creekdale – landscaper's equipment worth \$2000 stolen)
 - Overall crime is declining. Hope for this to continue as we face end-of-year incidents, particularly porch pirates.
 - Chief of Police is actively engaging the community by visits to various locations, including a recent visit to the WHHA Rec Center.
 - VIN-etching event in November was successful, with approximately 40 etchings achieved, despite the cold!
